



Head of the Institution: 1.

The Institutions, which have not yet appointed qualified Directors/Principals as per the norms of the Council, may be granted conditional approval. Conditional approval so granted will be displayed on the website. Such Institutions will be required to appoint qualified Director/Principal by 30th June, 2007.

2. Faculty:

Institution which fulfil the following conditions may be granted extension of approval

- Minimum of 75% of required faculty should be available excluding cadre ratio. However, the institution will be issued a warning letter regarding appointment of faculty in proper cadre ratio i.e. 1:2:6 on or before 31st August 2007
- If the shortfall is > 25 % and up to 50% the intake is to be reduced by 25%. If the shortfall is > 50% then the institute is to be placed under no-admission category.

Faculty for B.PHARM. BHMCT and BFA courses may be calculated on the basis of total sanctioned intake of 1st, 2nd, 3rd and 4th year and divided by 15 (for BFA, if it is 5 year course then the sanctioned intake of all 5 years is to be divided by 15).

Faculty for M.PHARM-minimum of 1 Ph.D. qualified and 1 PG qualified faculty should be available for that programme.

Regarding part-time courses the faculty for full time course only will be considered.

Faculty is to be considered for existing strength only.

Temporary Site: 3.

All Technical institutions which are functioning on temporary location/ site will have to either shift to its approved permanent site with proper building and other facilities as per requirement before 31st March 2007 or be closed down from the academic year 2007-2008.

4. Built up area:

The institutions having 100 % built up area (shortfall up to 10% to be condoned) on the basis of sanctioned intake be granted extension of approval.

If the shortfall is > 10% and up to 25 %, the intake has to be reduced by the 25%.

If the shortfall is > 25% and up to 50%, the intake has to be reduced by 50%.

If the shortfall is > 50% then the institute is to be placed under no-admission category. The built-up area is to be considered for existing strength only.

Essential requirements of built up area per student for:

- MBA/PGDBM 10.4 Sq.mtrs.
 - Pharmacy 15.6 Sq.mtrs.
 - MCA 9 Sq.mtrs.
 - HMCT 15 Sq.mtrs.
 - BFA 16.9 Sq.mtrs.

5. Mandatory Disclosures:

The Institutions which have not submitted Mandatory Disclosures alongwith the compliance report and whose Mandatory Disclosure is not available on website may be issued show cause notice for the same.

- 6. The institution violating the norms of the AICTE by running **unapproved progrmmes / unapproved Foreign University programmes** in the premises of AICTE approved courses will be issued show-cause notice for no admission / withdrawal of approval.
- 7. The institutions which have **not implemented AICTE** pay scales to teaching as well as non-teaching staff will be required to implement these scales before start of the next academic session.

- 8. If an institution is having deficiencies in all the essential parameters i.e. Faculty, Built up area, Computers, Lab facilities, Library Books etc. then the institution will be laced under no-admission category.
- 9. Period of Approval:

Institutions that does not have any deficiencies with respect to the parameters mentioned below, may granted one time extension of approval up to five years. However, such institutions will be required to submit compliance report along with processing fee and mandatory disclosures every year by the stipulated time.

- (a) 100% faculty in all the course in proper cadre ratio
- b) Availability of qualified Director/Head of the institution
- c) 100% built up space
- d) Implementation of AICTE pay scales to teaching & non-teaching staff.
- e) Institutions not violating any AICTE norms or indulging in malpractices
- (f) Availability of Mandatory Disclosure on Website
 - g) No deficiency in terms of Library, Labs, Computers or any other essential shortcoming
- 10. The extension of approval of the institution will not be discontinued on the basis of shortcoming in the following parameters for the year 2007-2008. However, the institution will be issued a warning to improve the same.
 - a) Computer Facilities
 - b) Library facilities
 - c) Academic performance
 - d) Placement activity.
 - e) Financial Position
 - √f) Hostel facilities
 - g) Common room
 - √h) Electric generator
 - i) Approach Road
 - j) Medical facilities
 - k) Portable water availability, etc.
- 11. Violation of AICTE norms by making excess admission against the sanctioned intake or any other violation.

Excess admissions shall not be allowed under any circumstances. In case any excess admission is reported to the Council, appropriate penal action will be initiated against the institution as per approved decision of the Council.

Apart from the above broad guidelines the AICTE may take any other appropriate action / impose penalty as deemed fit on the basis of the expert committee report / compliance etc.

RESTORATION POLICY

It has been observed some of the institutions are not able to comply with the minimum norms & standards prescribed by the Council. However, the broad parameters on the basis of which the courses / institutions have placed under Reduced Intake / No Admission category are given above:

- 1. The faculty deficiency in a particular course being more than 25%.
- 2. The built-up area deficiency being more than 10%.

In view of the above it is decided that such institutions may be given the opportunity of restoration of their intakes after rectification of the deficiencies.

The following categories of institutions would be considered for restoration of intake for the year 2007-08.

i) Faculty deficiency:

The institutions which are able to rectify the deficiency of faculty by appointing additional faculty in the relevant discipline by 31st May 2007 may be restored proportionately. Documents required for restoration are copies of: (a) the Advertisement with date & title of Newspaper; (b) Minutes of the Selection Committee Meeting comprising of external subject experts and preferably University nominee; (c) Appointment orders issued; (d) Bio-data of the selected faculty members with attested photographs; (e) Joining Reports. The documentary evidence thus submitted should be attested by the Chairman / Secretary of the Society / Trust.

ii) Built-up Area deficiency:

The institutions placed under Reduced Intake due to the deficiency of non-availability of adequate built-up area as per AICTE norms may be asked to submit the latest status of the availability of built-up area in their institutions. In case any built-up area has been constructed after submission of the compliance report in August 2006 or the date of the Expert Committee Visit the same should be submitted along with the documentary evidence like: (a) Photographs of the additional area constructed; (b) Details of the built-up area certified by the Chartered Engineer / Architect before 31st May 2007.

In case the deficiency of built-up area continues to persist and the institution expresses its inability to comply with the condition of availability of built-up area as per AICTE norms the Council may insist upon such institutions to submit an affidavit on Rs. 100 stamp paper on or before 31st May 2007 stating that the built-up area deficiency would be complied with on or before 31.08.2007 for restoration of intake.
